**Textbooks.** Linear Algebra and Differential Equations using MATLAB by Martin Golubitsky and Michael Dellnitz. Available free online at the website listed on Carmen/Canvas.

**Prerequisites.** A grade of C- or above in 1172, 1544, 2153, 2162.xx, 2182H, or 4182H; or a grade of C- or above in both 1152 and CSE 2321. Not open to students with credit for 4568 or 5520H.

**Emails.** The professor prefers students to speak directly to him either before or after class or in office hours. Any emails to the instructor must be from your university email address and be signed with your first and last names.

**Technology.** Use of laptops and tablets in class is permitted, but not during exams. If you think that your use of your devices may be distracting to other students, please sit towards the back of class. If you must text or surf on your phone, please keep it where no one can see it.

**Homework.** I will assign weekly homework assignments. Homework will be due at the beginning of lecture. The assigned problems are a lower bound of what the student is expected to do. Students may work together to solve the problems, but each student is responsible for their own solutions. In particular, students must write up solutions separately, and any copying will be regarded as academic misconduct/plagiarism. Students may use whatever resources they want for their homework, but they must cite all resources.

**Exams.** There are two midterms and a final exam.

Midterm 1: Friday September 27 during lecture

Midterm 2: Friday November 1, during lecture

Final exam: Monday December 9, 10-11:45am

There will be no makeup exams. A missed exam will count for a zero for that test. (See grading option (2).)

**Grading.** There are two grading options for each student:

- (1) 20% Homework 20% Midterm 1 20% Midterm 2 40% Final
- (2) 20% Homework 20% Higher midterm 60% Final

The instructor will automatically pick the option that results in a higher grade. If a student must miss more than one test for reasons beyond their control, in extremely rare circumstances, with prior consent from the instructor, the final will count for a higher percent of their grade.

**Grade revisions.** You may request that exams be regraded. This request must be *in writing* and be turned in by the end of the class or office hour during which your exam was returned. If you leave class or office hours with your exam for any reason, your grade revision request will not be accepted.
