Homework. I will assign weekly homework assignments. Homework will be due at the beginning of lecture. The assigned problems are a lower bound of what the student is expected to do. Students may work together to solve the problems, but each student is responsible for their own solutions. In particular, students must write up solutions separately, and any copying will be regarded as academic misconduct/plagiarism. Students may use whatever resources they want for their homework, but they must cite all resources. Lack of citation will be regarded as academic misconduct/plagiarism.

Homework will be due at the beginning of lecture on Mondays. Groups may choose to email me their homework before the deadline.

There is a strict format for homework. Groups should hand in a final copy of their homework on plain white paper without lines, perforations, or holes. Please use a new page for each problem. The final copy should represent the student's best effort, as homework counts for the entire class grade. Groups are encouraged to typeset their homework with LATFX, in which case they do not need to stick to one page per problem.

Quizzes. There will be a one problem quiz in the discussion section on Thursday of each week. Solutions will be graded out of 10 points. The lowest score will be dropped.
